What can we do to help stop Climate Change?

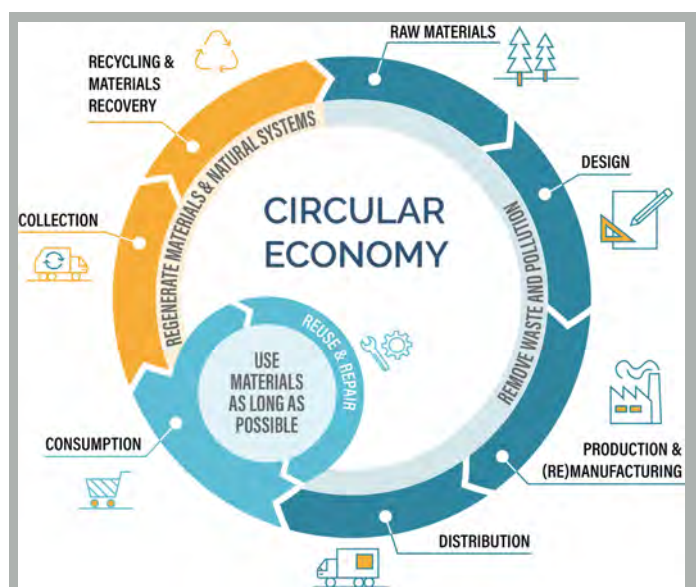
– Stop buying stuff! – Reduce, Reuse, Repair, Recycle!

This was an answer I recently heard to the question, 'What can I do to stop Climate Change'? A simple answer, but it's true. Our consumption is driving Climate Change, through all the emissions produced from making the items we are encouraged to buy, whether it's clothes, cars, mobile phones, or smart TVs. Additionally, our consumption is exceeding the Earth's capacity to regenerate those resources. The day in the year when we take more than our Planet can sustainably provide is called Earth Overshoot Day. Back in 1970, Earth Overshoot Day was on 30th December, this year it fell on 1st August!

Our planet can support the huge population of over 8 billion people but we have to live within planetary boundaries. For those of us living in countries which have developed economies we need to reduce our consumption by about two thirds, whilst in other parts of the world governments may need help to grow their economies to provide life essentials, access to clean water, food, healthcare, education, etc.

Reducing our impact by cutting consumption and eliminating waste is achievable, if we move to sustainable, circular economic systems. The graphic below of the Waste Hierarchy Triangle, shows the changes we can all make.

Do you need to buy a new item when you could borrow it instead? EarthLincs are hoping to open 'Stuff to Borrow' (Library of things) in the near future for all those things you need to use now and again but don't need to own, so you save money too. Try swapping, instead of shopping, 'Swishes', (clothes swaps) are great places to refresh your wardrobe. There are now a number of website available, (e.g. Vinted), where you can buy pre-loved clothes and other items, and you can also visit your local charity shop. Use items again and again, and if it breaks – repair it. Repair Cafés are opening up all over the country, where you can get household items, clothing, tools, electrical appliances, bikes, etc, repaired for free! You can find them locally in Lincoln, Louth and Sleaford. For bigger appliances you will find tradesmen locally to repair your electrical items. Should you find you no longer need something, don't store it, rehome it – social media can help you do this with FaceBook, 'Owt for Nowt' sites. Finally, when it can no longer be reused, repaired or rehomed, it's time to recycle it, further minimising waste.

Victory for SOS Biscathorpe!

The Planning Inspector's decision to allow oil production in Biscathorpe in an Area of Outstanding Natural Beauty has been quashed after concession from the Secretary of State.

Permission was first granted to drill for oil at Biscathorpe in 2014 and the current application for further exploratory drilling and 15 years of production should oil be found was refused by Lincolnshire County Council in 2021. This decision was overturned by the Planning Inspectorate in November 2023 after the applicant, Egdon Resources UK Ltd (now owned by US-based group Heyco Energy), appealed against the decision.

However, permission was then granted for a statutory review hearing before a judge at the Royal Courts of Justice in London, and following a landmark Supreme Court ruling, which halted a similar plan for oil production in Surrey, defendants the Secretary of State for Levelling Up, Housing and Communities and Egdon Resources accepted an invitation from solicitors on Leigh Day's environment team to concede the case.

Biscathorpe capaigner, Mathilda Dennis said: 'We're delighted that all the hard-work and campaigning over the last 10 years has finally paid off, not just for the beautiful area of Biscathorpe, but we hope that it will also help and encourage other groups fighting similar battles; on the back of the Finch ruling and now also SOS Biscathorpe, it is clear that the unequivocal link between fossil fuel extraction and climate crisis can no longer be ignored.'

Amanda Suddaby from SOS Biscathorpe added: "It was also encouraging to see that these very senior judges seemed to recognise and value the importance of public participation in addressing the enormous issue of climate crisis. Our hope now is that this paves the way to a full and proper understanding of the great harm that each and every new fossil fuel development represents.'

Leigh Day solicitor Julia Eriksen, who represents the campaigners, said:

'This case illustrates the significant implications of the Supreme Court's landmark judgment on fossil fuel production in June, which ruled that planning inspectors must take into account the downstream emissions from burning fuel when considering fossil fuel applications.

We hope this success in Lincolnshire is a positive sign for similar cases still before the courts.'

Lincolnshire County Council need your views!

Lincolnshire County Council are seeking views on a new blueprint for oil and gas planning in the county for the next 15 years. The draft 'Lincolnshire Minerals and Waste Local Plan' is at the 'preferred approach' stage, and the county council plan to adopt the final version of the plan in 2026. It is important that we let the council know our views now, so that they can be taken into account as the plan is updated. It is a long report, 129 pages, but the key sections are: 1. Introduction, 2. Legislative and policy context, 5. Overarching strategic policies, and 6. Providing for minerals, pages 40 – 43 are about Hydrocarbons (oil and gas).

The plan acknowledges the need to mitigate and adapt to climate change as a core principle, but based on strategies and guidance put in place by our previous government, this plan would permit the development of new oil and gas production in the county. The United Nations and the International Energy Agency both state that there is no need to issue new oil and gas licenses as we transition to renewables, indeed it is imperative that there should be no new drilling, if we are to limit Global Warming to 1.5 degrees.
